2. Lilliputiens - Belgium privacy policy

At Lilliputiens S.A., our customers are very important to us and we take the protection of our customers' privacy very seriously. This is why we promise to respect the Belgian law of 8 December 1992 on protecting privacy with regard to personal data processing. By using our site, you automatically accept our privacy policy and agree to the collection and processing of your data in accordance with the methods and principles described below. We do this to adapt our site to your preferences, for marketing purposes, to respond to your requests and to improve our online services.

While you are browsing our site, your personal data may be collected, for example, when you subscribe to our newsletter by filling in a form with your personal details, or it may be collected by different technological tools associated with the internet, such as cookies, IP address, social plugins, etc. without you actively providing us with this information.

In particular, the following information is collected:

- Your domain (automatically detected);

- all information about the pages you have visited on our site;
- any information you have given us voluntarily (for example, in connection with site surveys and/or subscriptions, questionnaires, competitions, etc.).

The system provides you with an "opt-in" feature, allowing you to state which marketing information you do not wish to receive. This explicitly excludes:

- informative, promotional or marketing content that may be included in service notices necessary for processing customer requests and orders;

- pop-up adverts that may be activated on the site in order to personalise your experience, including the type of offers displayed on the site;
- information on your browsing habits and navigation through the site for the purpose of managing site activity. This data may be sent to the technical sites of suppliers or partners for the purpose of optimising technical performance or statistical processing.

In the event of erroneous, inaccurate or incomplete data, you will obviously be able to ask us to rectify this information. You always have the right to object to your data being sent to a third party, the right to object, free of charge, to your data being used to send you marketing requests and, in general, the right to object to any sort of data processing. Consequently, if you would like us to remove your data from our database, you just need to send us a letter or email to the addresses mentioned above. We promise to remove your data as soon as possible.

If you believe that our site does not respect the regulations on privacy protection, you can contact us by sending us an email or letter to the addresses mentioned above. You also have the right to submit a complaint to the Commission for the Protection of Privacy.

3. Use of cookies

What are they? Cookies are small data files sent by a website to your browser and accepted by the latter. They show that you have already visited the site in question. These cookies are stored on your hard disk. They can either be set by the server of the site that you are visiting or by partners of this site. Don't worry, cookies only read their own information. They do not have access to other data. They contain the name of the server which set them, an expiry date and a unique digital code.

What are they for? Cookies make it possible for a website to be adapted to your requirements and preferences. Cookies also allow the contents of a website to be personalised in order to improve your browsing experience.

What cookies are used on our site?

The Lilliputiens site includes the following cookies:

- **Cookies that identify you:** they allow you to fill in forms easily, follow the contents of your wish list and so on. These cookies also check your identity: they prevent access to your personal data by other people.
- **Cookies that make your life easier:** these cookies make browsing easier for you by remembering your preferences, for instance, your language of choice.
- **Cookies that let us get to know you better:** they count the number of visitors and identify the most popular web pages. Thanks to this information, we can improve our website.

How can you disable them? Actions of Lilliputiens cookies are restricted to those described above. But you can also disable them.
